Thank you for this update.

I also wanted to confirm a couple of things.

Back in August, and confirmed again in the fall, Chris said that BOT would take the section of Bear Rock Road between the Heath Road and Harvey Swell Road (Stewartstown and Colebrook) off of the state maps, and remove it from the state system, including signage. I just wanted to confirm that this is still the case, as I have not heard anything since last fall. Could you please

ask Chris to confirm that BOT will take those actions?

Also, I reached out to that landowner and they should be calling you. He is somewhat curt, just a head up.

Hi John- I just spoke with Chris Gamache who said he was recently in a meeting that your Mom requested with DOT. This email should represent what was covered in that meeting.

The Trails Bureau intends to meet with the Select Board of Stewartstown to try to identify re-routes for the upcoming season. Longer term solutions are currently being negotiated with private land owners to alleviate on-road riding concerns as well.

There will not be a sign calling Bear Rock Road "Bear Rock Trail".

There is a meeting scheduled for the end of this month that Chris has been invited to attend to discuss the signage plan.

As Chris stated to your Mom the other day, final decisions and routes will be done by the 2nd week of May.
