From what I can tell, the pushback you'd get is about the Diamond Pond Route being longer. True, but only by 5-10 minutes. These roads were ostensibly opened to connect the main riding areas to each other, so an extra 5-10 minutes isn't much in the context of Stratford to Pittsburg, or Berlin to Pittsburg. The other point is that Diamond Pond doesn't have the dust and fine particle concerns that we have.

He made it clear that he has no interest in helping alleviate the situation on Bear Rock Road, and that in fact the Colebrook Selectboard is deferring all such decisions to the Metallak ATV club, despite the fact that it is Colebrook's legal responsibility, not the club's. This is frustrating beyond belief when the club told me back in November that they're not against closing the road.

Hi Chris,

I hope you're doing well wrapping up snowmobile season.

I don't know why I didn't think to forward this earlier, but this is the email from Arthur Beauchemin regarding our section of Bear Rock Road (between Harvey Swell Road and the Heath Road). Again, the club is basically not taking a position, neutral, however you want to describe it, but not against closing it.

On the actual road itself, the residents in Colebrook who live on it support closing it. In Stewartstown, four are in favor of closing it, as am I. One person ATVs, and is ok with closing it, given that the Selectman allow her to travel the short distance from her house to Noyes Road. No one has a problem with that. One selectman with whom I've spoken, Alan Coates, thought that would be reasonable, though I haven't spoken with him on that particular point in at least a month.

Please keep me up to date on how conversations are going. Again it is my hope that we can have this section taken off the state map and system, and that my family can actually enjoy our home this summer without having to worry about our health and safety.
