Hi Chris,

Based on our field review yesterday, I would like to offer the following:

- \* The northern crossing located at the Beach road intersection appeared acceptable as far as sight distance and geometry. We would be able to permit this location for a trail connection from Beach Road to points beyond, preferably with a connection being made in conjunction with the 3rd bullet below.
- \* The crossing located at Spooner Road did not have the required sight distance and we would be looking to deny it based on that.
- \* The crossing located between Spooner road and the Buck Rub is not a thru trail, and as you know, we have always tried to limit the number of trails within the right-of-way to those that are part of the overall trail system. However, if there were a connection to points beyond the Buck Rub to Spooner road and the many residents / camps on the West side of US-3, then we would be amenable to permitting this location as there is adequate sight distance.

I also wanted to share the attached letter we received, if you were not already aware. I know that this direction may upset some of the folks in the area, and I understand their frustration. To that end, I do hope that a connection could be made to get them the access they desire. Let me know if you have any questions and how you would like to proceed after you have had a chance to review things.
