Clements, Commissioner of Public Works and Highways, pursuant to his authority under RSA 228:67 and with the approval of the Governor and Executive Council given on May 2, 1984, for \$27,000 and other valuable consideration paid, grants to Franconia Investment Associates, whose address is <a href="color: blue;">c/o Isaacson Structural Steel/P.O. Box 67/Berlin, NH,</a>, with Warranty covenants a certain parcel of land in Lincoln, New Hampshire more particularly described as follows:

The most northeasterly portion of the so-called Concord to Lincoln Railroad Line, being all that railroad land easterly of a line which connects the westerlymost boundaries of lands already owned by the grantee as those lands abut on the north and south the parcel herein conveyed, said line running approximately through railroad centerline station ll15+75. Surrounded on the north, east and south by land already owned by the grantee, and bounded on the west by other land of the grantor.
