SNOWMOBILE HIGHWAY CROSSING PERMIT

Permission to construct and maintain a trail crossing for snowmobiles on Route 13 pursuant to the location and specifications described below is hereby granted. Failure to adhere to all provisions set forth below and failure to complete construction and perform adequate maintenance of said facility shall render this instrument null and void. This permit will be revoked if property owner adjacent to highway on whose land the trail extends withdraws permission. Facilities constructed in violation of these conditions shall be corrected immediately upon notification by a Department representative or the costs of removing said facility shall be fully borne by the permittee.

LOCATION In Brookline, approximately 576 feet north of the intersection of Route 13 and Hood Rd.
N 42.78596 W 71.65900, SLD 32594

1. The trail shall match existing grades within the limits of the highway right-of-way.
2. One trail crossing is permissible with the travel portion of the trail being a minimum of 12 feet wide but not exceeding 20 feet in width.
3. Trail signs reading "STOP" shall be erected on each side of the crossing at the right-of-way limits and advance warning signing a minimum distance of 100 feet from the right-of-way line advising trail user of the highway crossing ahead.
4. No structures, including buildings, shelters, permanent signs and lights, displays, walls, etc. shall be permitted on, over or under the highway right-of-way.
5. No parking of motor vehicles and/or trailers used to transport OHRV or any catering or servicing shall be conducted within the highway right-of-way.
6. The highway right-of-way line is located (50) feet from the highway centerline.
7. No part of the highway right-of-way may be used by OHRV for any purpose other than direct crossing.
8. Snow windrows shall be groomed by the permittee or his agent to provide adequate sight distance and a gently sloping crossing approach.

SNOWMOBILE TRAIL CONNECTOR PERMIT

Permission to maintain a snowmobile trail connector within the State owned right-of-way of Route 13 in Brookline is hereby granted subject to the conditions enumerated herein.

LOCATION: On the east side of Route 13, approximately 286 feet north of Hood Rd., (SLD 32318 RT.) (N 42.785243 W 71.659239) running north approximately 290 feet, (SLD STA 32304 RT.) (N 42.78596 W 71.65900) to the proposed crossing.

1. Trail shall be as shown on plan attached to this permit. Said plan shall be considered a condition of this permit.
2. Trail signs shall be erected and maintained to warn of traffic at all crossings (drives and public ways).
3. Trail signs shall be erected and maintained at each terminus of the permitted connector to advise the necessity of remaining on the designated trail connector at all times.
4. No other portion of the highway right-of-way outside the designated trail connector and any permitted trail crossing is authorized for use.
5. The trail connector must be physically closed for the entire snowmobile off-season.
6. All required fencing must be erected and maintained under the direction of the Bureau of Off Highway Vehicles.
7. No parking of motor vehicles and/or trailers used to transport snowmobiles, or catering or servicing shall be conducted within the highway right-of-way.
8. Snowmobile traffic is two-way on the connector. Speed shall be reasonable and safe as advised by the Bureau of Off Highway Vehicles.
9. Trail to be properly signed and maintained in a safe condition.
10. A safety rail shall be installed over the existing box culvert as shown on plans submitted.
