Hi Jamie,

We went to all flagged locations of the phragmites and didn't see any evidence of plants. I'm not sure why there weren't plants in the unsprayed section, unless they did get sprayed after all by Fish and Game and it was a miscommunication. We will continue to monitor annually. In the spring/summer, we plan to take gps points of the locations of found plants, which we did not do in the past, however, we did flag locations and the flagging was still evident.

The trail is always closed on October 15 for the season. Different clubs and areas close their trails at different times throughout the fall.

This last point will have to be something that is discussed further. The draft minutes from the last NSCAC meeting should be posted on our website in the next couple of days.

I note that the 2021 KN Compliance report stated that glyphosate was applied to 3 of the 4 sites where phragmites were detected, and the 2022 report stated that no phragmites were detected. Was the unsprayed site visited in 2022? If so, what may

have caused the disappearance of phragmites in the unsprayed site?

Was KN closed on Oct. 15 because of the issues that prevented comprehensive maintenance in 2022?

Given F&G's ongoing concerns about noise impacts "when song birds are nesting/ fledging and mammals are in the early days of raising young," and the report that 1056 ATVs passed counters on Corridor C-North on the two day period of May 28-29, 2022, shouldn't KN be closed throughout May and June *at a minimum*. If CORD does not close KN at its January 2023 meeting, KN ought to be closed at least until July 1.
